## FOREIGN UNIVERSITIES AND COLLEGES

If you have attended a college or university outside the United States, you will need to file an application with one of the foreign transcript services listed with the National Association of Commercial Evaluation Services (NACES). These services operate for a fee based on the extent of education evaluated.

Request the evaluation service to forward a letter to the EHS Registration Program stating that your degree is equivalent to a bachelor's degree offered by a United States college or university, listing each course completed with semester equivalency and all laboratory sections including **inorganic chemistry**, **organic chemistry**, **physics**, **biology**, **microbiology**, **and calculus or college algebra**.
